REHS Monthly Reports: Ms. Dillon went over the submitted report and discussed the following inspections:

Members inquired about inspections at Café Amore, 5 Colebrook Court, Krauszer’s, 56 Oak Street and Park Ave Tattoo. Ms. Dillon went over the specific reports but commented that she did not do those inspections personally. Ms. Dillon spoke about the remodeling at El Azteca.

Immunization Reports: The Board went over the submitted June-July-August 2019 reports.

County Animal Control Reports: The Board went over the County Animal Control Reports for June-July-August. It was suggested that we invite Mark Byrnes from Bergen County Animal Control to our next meeting to answer some of the Board members questions. Ms. Tardibuono will contact Mr. Byrnes.

Water & Sewer Reports: Christopher O’Leary – The Board went over the submitted May-June-July 2019 reports. All samples were in compliance with DEP regulations.

MMWR: Ms. Szot reviewed Surveillance Summaries Reports and spoke about the following issues: norovirus, hypertension, second hand smoke, acute myelitis, drug users and prescribed opiates, candida, polio, salmonella, hpv vaccine & meningitis in 13-17 year olds, rabies in rats, babesiosis, COPD, CPS and a study conducted in Japan.

Stigma Free: There was no meetings over the summer. The next meeting will be scheduled in October.

Council Report: Councilwoman Epstein spoke about the Mayor and Council modifying the ordinance on feeding wild animals.

Old Business: The rabies clinic is scheduled for November 12, 2019.
