HONORING TAYLOR WHANG**

WHEREAS, Park Ridge resident **TAYLOR WHANG**, a junior at IHA, saved the life of a young man while working as a lifeguard at the Park Ridge Municipal Pool; and

WHEREAS, **TAYLOR WHANG** has worked as a lifeguard for the past 2 years; and

WHEREAS, this past July, **TAYLOR** was working her summer job as a lifeguard at the Park Ridge Municipal Pool, when she saw a young man drowning; and

WHEREAS, TAYLOR WHANG immediately and effectively retrieved the drowning young man from the water and brought him to safety; and

WHEREAS, because of **TAYLOR'S** steadfast efforts, attentiveness and quick response, along with the Pool Staff and the Tri-Boro Volunteer Ambulance Corps, the young man was rescued and treated for his injuries;

WHEREAS, it is wholly fitting and proper that **TAYLOR WHANG'S** valor, where she demonstrated an exemplary concern for the life of another, be acknowledged by the Borough of Park Ridge;

WHEREAS, the Mayor and Council of the Borough of Park Ridge, and all residents of the Borough, appreciate the heroic actions and wish to recognize and honor **TAYLOR WHANG;**

NOW, THEREFORE, BE IT RESOLVED on behalf of the grateful citizens of Park Ridge and the Governing Body, that I, Keith Misciagna, Mayor of the Borough of Park Ridge hereby extend our sincere congratulations and appreciation to **TAYLOR WHANG** for saving the life of the young man and for being a shining member of our community.

Speaker - Andrew Lewis: Good evening. I happened to be on duty as the Manager that evening, when a frantic call came from across the pool from one of the other lifeguards. When I looked up, she had saved the young man from the diving-well area - so he was going under for sure. She truly saved the life and I am so grateful and so very proud of her at the same time. I couldn't be any more proud of her....**Taylor Whang.**

Mayor Misciagna calls up James Babcock, Chief Madden and the Police Brass to the Podium:

Mayor Misciagna: This is a great night! Jim is our Sergeant and we will be making him a Lieutenant. He has been a great example for a lot of the new policemen we've had. He is what I like to think of as a "cops cop". He is extremely polite, very professional, but he doesn't take anything from anybody either. Chief Joseph Madden: Good evening everyone. Thomas Derienzo, Jr., Volunteer Fire Department Chief: Mr. Mayor, Thank you. On September 11th, the Fire Department buried our elder statesman, John Thomas. He was seventy (70) years on the Fire Department. They say, "with a little rain", well, "you have to have a little rain, for the sun to shine". Well tonight, the sun shines! We have a replacement for John – we have a new member and we have two new - I'm going to call them "elder statesmen" now. This is the ninth time this year I have been up here. That's a testament to this Borough. For a small town to swear in nine different people, is phenomenal! I think that's great for the community spirit here. Seeing tonight, seeing everybody out here, that's awesome. Anybody that wants to join, please see me and I'll give you an application. I would like to thank the Mayor and the Council for their continuing support. I would like to welcome our newest member, Vahak Hanessian, and to Ex-Chief's Babcock and Ludwig, congratulations on fifty (50) years of service to the Department!

Mayor Misciagna: Both of these gentlemen are truly Park Ridge's finest employees and I refer to both of you as "Mr. Park Ridge". I would love for you both to say a few words.

Robert Ludwig: It was 50 years ago and we were standing in this exact spot, when we were sworn in and took the oath - similar to Lieutenant Babcock tonight and our newest Fire Department member. I just wanted to talk a little bit about Park Ridge, how long our family has been here and what it means to me. This past month, my granddaughter, Molly, went from kindergarten to first grade in the Park Ridge school system. Exactly one hundred and ten years later that her great-great grandmother did the same thing in Park Ridge. It was a 100 years ago this year that her great-great-grandfather was foreman of Century Hook & Ladder in Park Ridge – the equivalent of a company officer at that time. So, it's been a long time and I have a lot of recollections. Over that time, there has been a lot of major fires. I think one of our firsts was the Leach Manor fire on Fremont which was pretty catastrophic at the time – going on to the various Bratt & Doxy Lumberyard fires, you might remember, that also were pretty devastating at the time. More recently, the Cycle Sport and Krell Lighting fires, and only a short while ago, our only fire fatality in probably several generations. So, it's been a long fire history as it relates to the many other things that we have done. I can thank Park Ridge for allowing me to be part of the planning aspect – planning as it relates to some of our great projects. I was there during the planning stage and the dedication of the Lehman Gardens with Marge Roukema, the planning and opening ceremony at Hertz, the planning and grand opening of the Marriott, the grand opening at Sony and including the formal grand opening of Bear's Nest Village.

It's been very fulfilling, but probably the most fulfilling thing that I have done is, with my time as an officer, and the time on the Personnel Committee of the Utility Board, where I had the opportunity to interview, help the career path, recommend promotions, and in some cases, even see their retirement for many, many firemen and nearly all of the Operational Staff of the Borough, over the last 30 years. Again, thank you Chief, thank you Mayor, and thank you Council.

James Babcock: I just want to thank everybody. I put a lot of time in town, but I loved it! Fifty (50) years in the Fire Department, seemed like it flew by and 38 years with the Borough – but they are all good times! I would just like to say, thank you very much!

Mayor Misciagna - speaking to Mr. Ludwig - if you wouldn't mind staying up here for just one minute longer - I have one more thing. Bob is the recipient of the William D. Diedtrich Memorial Award this year and I have a Proclamation that I would like to read:

Mayor Misciagna: When preparing this Proclamation we only concentrated on his fire career -- if I was to talk about everything else he has done with the Utility Board and working with the Borough, it would last so long. He is truly, "Mr. Park Ridge" and I am truly glad he is home to receive this. Congratulations!

AGENDA CHANGES

PUBLIC PRIVILEGE OF THE FLOOR:

Mayor Misciagna asks if anyone present wishes to be heard on any matter.

Upon recognition by the Mayor, the person shall proceed to the floor and give his/her name and address in an audible tone of voice for the records. Unless further time is granted by the Council, he/she shall limit his/her statement to five (5) minutes. Statements shall be addressed to the Council as a body and not to any member thereof. No person, other than the person having the floor, shall be permitted to enter into any discussion, without recognition by the Mayor.

Speaker #1 – Will Fenwick – 5 Mae Court: I checked on ECourts this morning regarding the status of the Hornrock Litigation and I didn't see any Order issued by Judge Padovano. I was wondering if the Borough had heard anything or if they had heard anything from the Judge's Clerk as to if an Order is being released soon?

Mayor Misciagna: I have not heard anything - maybe our Attorney can speak on this, as to what he knows, but he has not made a Ruling yet.

Carmin Alampi, Esq.: That's exactly right. The Judge heard our little argument and reserved a decision. He has to ponder what methodology will be used at the scope of Trial, and whether any additional expert witnesses will be permitted. So, we are waiting with baited breath.

Will Fenwick: Alrighty. And again, I see Ordinance No. 019-025 - "Amending the Feeding of Wildlife" is up for a vote tonight, and I just wanted to thank again the Council for putting that Amendment forward and again, reiterate - I think that that will solve the issue of any ambiguity in the ordinance completely, and put the issue to rest. And, my final question is: I noticed that the Inter-Municipal Nature Trail is up. There is a Resolution for a License and I had spoken to Mayor Rendo about this a while back. Do you know if they are going to be moving any of the fences surrounding the SUEZ property in Park Ridge or in any of the other municipalities involved in this?

Mayor Misciagna: The Administrator can speak on this as she has been involved with the nuts and bolts of it, but we have been working on this for years. There will be a fence, with a gate near Sulak - so you can enter the Trail from Sulak - you will be able to walk from Park Ridge - kind of in the right field of the High School baseball field - there will be an entrance there. It will continue through Woodcliff Lake all the way to Hillsdale.

So, that will be a direct line, about 30 feet from the railroad tracks – that doesn't need any fencing other than gates to come and go, at the present time. The ultimate goal is to make basically a lower case "b". So you could start at Hillsdale, you could walk through Woodcliff Lake, through Park Ridge and then the most beautiful part of the whole trail is, in Park Ridge, but that's where there is a lot of water, so that is where some work is going to have to be done down the road. But the first phase, which we are starting right now, is going to start at our Sulak Field and is going to go straight through to Hillsdale.

Will Fenwick: Alright, yes. The reason I am asking is that I actually used to get fishing permits from SUEZ to go fishing in the reservoir there, and so I am very, very familiar with it, and this might be a question that is better asked to SUEZ, but I know that in the past, because I was a permit holder, they were very restrictive. They had people patrolling and they would actually kick them out if they didn't have their badges on them. So, I am sure they are changing that policy, somehow, but again that might be a question better for SUEZ.

Mayor Misciagna: This is going to be completely different. I, too, used to take my son fishing there on the dock in Woodcliff Lake – it was a nice program they had. There is no pass any more. It is going to be open-passive recreation. It won't be a concrete trail, but it is going to be a stone like a QT type of trail, so you could walk through it. It's going to be a carry-in, carry-out, there is not going to be garbage cans there. So, they don't want people dropping garbage - so if you bring something in, they will expect you to bring it out.

Will Fenwick: That was the way it was beforehand for the permit holders. Do you know if they are going to be allowing fishing, in the reservoir, from residents without a permit? Is that what you said?

Mayor Misciagna: The ultimate goal is that they are going to let various passive recreation – the Riverkeeper is going to bring in kayaks and there will be times during the year that you can actually go out and paddle a boat. So, yes, we are hopeful that's all going to be part of the ultimate agreement. You will be able to fish as well. You will have to have a fishing license. This won't be any different than going to Electric Lake and throwing your hook in the water.

Will Fenwick: You answered all of my questions. Thank you very much!

Councilmember Mintz: Mr. Mayor, I think you are going to make a presentation about it at the next Council Meeting.

Mayor Misciagna: We are – we will have the mockup, the drawings and an aerial view of the whole thing. It is going to be, what I think is going to be like our "Central Park of the Pascack Valley", so I really think it is going to be something special. We have been working on it for years, so, we are very fortunate. There are a lot of people interested – the DEP wants to make sure that it's done properly, SUEZ is concerned about safety, we are concerned about policing and the costs associated with it. We have been vetting it out for several years, and I am thrilled that Woodcliff Lake passed a resolution last night to hire a contractor to begin the building of it. So, hopefully, we will have some additional information as to when it is going to be completed and at the next meeting we will be talking about it.

Speaker #2 – Lori Fredrics – 5 Duke Court: First of all, I want to just congratulate the Council for the amazing Festival that we had in town on Sunday. It was SO much fun and amazingly well-attended! I went to High School with James Gandolfini and was part of the whole movement to rename the street. I was just so pleased that – it's what I think everybody wanted and meant from the beginning - that James would not be forgotten and that his legacy would continue, and this was just an awesome part of doing that. I was very, very pleased and I thought that it was different in a way from a lot of festivals – like the Bocce ball – it was just very cool. I know it was a lot of hard work for everybody and I was really impressed. As my business here in town, Bergen Build Tonto, is actually an Italian singing specialist service, I want to offer my help the next time we do a festival. I have an idea to have an Italian Song Contest, which I think could add some flavor to what you are already doing. I have done such things before. There is a lot of talent in the metropolitan area and there are a lot of singing competitions. A lot of them are opera, and I was thinking more on the lines of Neapolitan songs or something like that. I would offer help to bring that to the next festival that you have. It could all be done – a lot of the funding for the prize money could all be done with entry fees. So, anyway I wanted to put that out there and again just again say how awesome Sunday was and how much I think the community really appreciated all of the hard work put into it!

Mayor Misciagna: Thanks, Lori. We are going to talk a little bit more about it later on in the meeting, but I do want to recognize that you were the one that brought the street naming of James Gandolfini to our attention. We were looking to honor him in some way and that came from you. So, we really appreciate it.

Lori Fredrics: It came from everybody - I just made the Facebook page

Mayor Misciagna: I want to recognize your effort, you are the one who started getting everybody organized. I was really grateful to be able to work with you on that. This is kind of the child to that. We can only do so much.

Lori Fredrics: I would like to see it continuing – I would like people in 20 years to remember....

Mayor Misciagna: Jim was very fill anthropic – so actually while we were doing it, we said Wounded Warriors was one of his special interests so maybe the next one we could do, maybe we could do a donation to wounded warriors. Maybe you could organize the singing contest and we could raise even more money and donate it to good causes. So, we appreciate it. Thanks. Thank you!




