WHEREAS, the Borough Attorney, after examination and consideration of all relevant facts and after performing all necessary due diligence, is of the opinion that the settlement proposed below is in the best interests of the Borough of Park Ridge; and

WHEREAS, the Borough Tax Assessor and the Borough Attorney, after independent review and upon consulting with each other, jointly recommend that these matters be settled according to the terms set forth below;

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Park Ridge, Bergen County, New Jersey, that the Borough Attorney is hereby authorized and directed to execute any and all documents necessary in order to settle this matter according to the following proposed terms:

1. The assessment for the tax year 2017 shall be reduced from \$24,000,000.00 to \$21,500,000.00.
2. The assessment for the tax year 2018 shall be reduced from \$24,000,000.00 to \$21,500,000.00.
3. The assessment for the tax year 2019 shall be reduced from \$24,000,000.00 to \$18,750,000.00.
4. Interest on refunds due shall be waived by the taxpayer if refunds are issued within 60 days of entry of Judgment.
