## MAYOR AND COUNCIL MEETING WORK SESSION December 12, 2023 7:00 P.M.

## Mayor Misciagna read the compliance statement earlier as required by the Open Public Meeting Act, P.L. 1975, and Chapter 231.

- 1. <u>Engineering</u>: Brough Engineer Dunlea spoke about Res. No. 023-348 TWA Application Endorsement - 1 Sony Drive (Landmark AR Park Ridge LLC) and his recommendation for the Governing Body to approve it.
  - a. Council President Fenwick asked about Leach and how a resident spoke about the gas leak in a road leaking. Brough Engineer Dunlea said they have to contact public service.
- 2. <u>Borough Administrator</u>: Brough Administrator talked about the polling and surveying conducted to gather public input about purchasing the North 5<sup>th</sup> property and applying for Green Acres, as well as the additional letters of support solicited.
