- The state of Park Ridge is good and it's improving. Just a year ago, our town had empty store fronts and a failing downtown that included a defunct waste transfer station, a closed saw-mill business, an empty supermarket, and most frightening to me, a Corporate Park that had two large empty office buildings. In just the past three months, we have received a lot of good news. The old A&P Supermarket site will now house a brand-new Lidl Supermarket within the next few months. Lidl, for those that don't know, is a German Supermarket chain and is extremely popular throughout Europe.

They will be a welcome addition to our downtown. We also welcomed a high-end jewelry store just recently; La Mirage on Kinderkamack Road, along with a brand-new pharmacy; Park Ridge Pharmacy that will be coming soon to Park Avenue as well as a children's place space store on Park Avenue. Our beloved Quackenbush Lumber will soon become Park Avenue Supply where you will be able to purchase garden products, light construction and seasonal products.

- These businesses, along with the new downtown redevelopment, that will include a stateof-the-art Community Center and promises to bring possibly two restaurants and additional retail – will bring an economic boom to our downtown that we have not seen in decades. We will, in the very near future, have a walkable, viable downtown that will bring excitement and much needed tax revenue to our Borough.
- That really pales in comparison to the wonderful news we recently received regarding our Corporate Park. After sitting dormant for several years, the Hertz building has announced that it has entered into an agreement with PIM; Promotion in Motion, a confectionary company that manufactures and distributes various candies such as Welch's fruit snack, fruit roll-ups, Sun Maid chocolate covered raisins and other well-known snacks. Promotion in Motion has experienced incredible double-digit growth over the past few years and I cannot be happier to have them as our newest Corporate resident. The move will bring approximately 150 new, good-paying jobs to the Borough, as they occupy 111,000 square feet, with an option to buy which the owner has expressed interest in doing within the next 5 years. Therefore, he will take up that whole 200,000 thousand square foot building. This is just a wonderful, wonderful thing for us. They are presently in the process of submitting plans to upgrade the facility with \$15,000,000.00 worth of improvements, just to start. With this, we could not have gotten better news for the Borough. It is my intention to meet with the owner, as soon as possible, to see how we can work alongside him to help them grow.
- So, we have a lot to be happy about in Park Ridge this coming year. That's not to say that we won't have our fights in 2020. I know why I was elected and I am going to do what the residents want me to do. We are prepared to go to Court for our Affordable Housing Plan, and it is our belief, that our Plan is fair and appropriate, and allows us to meet our obligation, while choosing developments our residents can live with. This fight will not be easy and winning will be difficult, but we will not settle for a Plan that doesn't meet our vision for Park Ridge. I would like to thank our Affordable Housing Attorney, Scott Reynolds, for all of his hard work over the past year, along with our Professional team; our Planner, Joe Burgis, our Engineer, Dan Lee of Neglia Engineering and others, who have really put us in a much better spot than we were just a couple of years ago. #### BOROUGH OF PARK RIDGE RESOLUTION NO. 020-001

#### **ADOPTING BY-LAWS FOR 2020**

**BE IT RESOLVED** by the Mayor and Council of the Borough of Park Ridge that the following shall be adopted and are hereby approved as By-Laws regulating the conduct of meetings; order of business; appointment and duties of committees; and other matters more specifically referred to.

#### **ARTICLE 1**

These By-Laws shall regulate the conduct of the meetings of the Mayor and Council of the Borough of Park Ridge and shall remain effective until the next reorganization meeting or until repealed, supplemented or amended at a regular meeting by the majority vote of the whole council. Any specific portion of the By-Laws may be suspended temporarily at any regular meeting for that meeting for that meeting only, upon the unanimous vote of the members present.

## ARTICLE 2 MEETINGS

1. Ordinances and Resolutions may only be acted upon at formal meetings which are advertised pursuant to NJSA 10:4-6 et seq.

2. The meetings of the Mayor and Council shall be held in the Borough Hall Council Chambers in accordance with the Resolution adopted at the Reorganization meeting each year setting forth the times and dates. Additional special meetings at which formal action may be taken will be scheduled as needed and in the manner provided by law. 3. The agenda for regularly scheduled formal meetings shall be set and distributed no later than the Friday preceding the formal meeting. Notwithstanding, the Borough Clerk may amend said agenda after distribution as necessary to include all pending business, and all agenda changes will be announced as part of the regular order of business.

The regular order of business at each formal council meeting shall be:

Pledge of Allegiance Roll Call Compliance Statement Agenda Changes Public Privilege of the Floor Ordinance Introduction Ordinance Public Hearing Consent Agenda Communications New Business Reports of Governing Body Approval of Minutes Optional Additional Public Privilege of the Floor Adjournment

4.

5. The Council may, by resolution duly passed at a meeting, dispense with a future meeting or designate a different date for any regular meeting.

6. Seating and Voting Roll Call shall be determined by the Mayor.

7. All formal meetings shall end no later than 11:00 pm.

8. The Public Privilege of the Floor at a formal meeting shall be limited to a 5 minute maximum per speaker. Nevertheless, at a meeting where more than 20 members of the public are present, the Mayor and Council may decide to shorten the allotted time for speaking in order to accommodate as many speakers as possible.

9. The public shall be permitted to speak at a work session as provided by law for a maximum of 5 minutes per speaker. The Mayor shall announce within a reasonable time from the opening of the meeting that the floor is open to the public for comments and will notify speakers of the 5 minute limitation.

10. Executive Sessions, commonly known as closed sessions, will be conducted as necessary in the manner prescribed by law to discuss only those matter allowed by law.

11. Pursuant to the New Jersey's Open Public Meeting Act, N.J.S.A. 10:4-7, any member of the Mayor & Council may participate in any closed session or public meeting by telephone communication device provided that the device being used is free from being intercepted and not be overheard by anyone. Participation by telephone communication shall not count for quorum purposes.

12. Only the Mayor and/or Acting Mayor (in the absence of the Mayor) can call for a vote in the public meeting for something not on the Agenda.

13. Mayor and Council will set aside the first Tuesday of December each year for a Special Meeting dedicated to Reorganization. At that time the Mayor and Council will invite any elected candidates that will be sworn in at the January Reorganization Meeting to this Special Meeting to discuss liaison and committee assignments.

14. Except as herein specified, Robert's Rules of Order Shall be used.

## ARTICLE 3 COMMITTEES OF THE COUNCIL

1. The regular standing committees shall be as follows:

Finance & Administration Fire Insurance Negotiations Operations Personnel Policy Public Buildings & Grounds Public Health & Welfare Public Safety

2. Each committee shall consist of at least one member of the Council and appointment to each Committee shall be made by the Mayor. Notwithstanding the foregoing, the Finance & Administration Committee shall have two members of the Council who shall be chosen from each political party, if applicable. If a subsequent vacancy exists for any Committee or Board Liaison appointment, then in such event, the Mayor shall make the appointment to fill said vacancy. -The Mayor, in his/her sole determination, shall make changes to Committee/Board Liaison assignments at any time during the year.

3. The Mayor, or the Council by a majority vote, shall have the power to appoint special committees for purposes other than those embraced in the duties of the standing committees. The Mayor, or the Council, shall have the power to appoint members from the Council or other citizens of Park Ridge as he determines necessary.

4. The Mayor shall be a member of all Committees, both special and standing.

5. All committees shall make a report to the Council either in writing or orally of their activities as necessary.

## ARTICLE 4 PAYMENT OF BILLS

All bills or claims against the Borough shall be processed and paid in accordance with the Code of the Borough of Park Ridge, Chapter 6, entitled "Claims Approval and Payment."

## 2020 CASH MANAGEMENT PLAN BOROUGH OF PARK RIDGE COUNTY OF BERGEN, NEW JERSEY

**WHEREAS,** N.J.S.A. 40A:5-14, Local Fiscal Affairs Law, requires that each municipality adopt a Cash Management Plan designed to assure the deposit, investment, and proper disbursement of local funds;

**NOW, THEREFORE BE IT RESOLVED** that the Mayor and Council of the Borough of Park Ridge does hereby adopt the following Cash Management Plan.

#### A. DESIGNATION OF DEPOSITORIES

The following institutions are designated as permissible depositories for the deposit of Borough funds:

Bank of AmericaValley BCitibankPNC BankLakeland BankTD BankValley National BankWells FaSovereign BankChase BankMariners BankNew Jerse

Valley Bank/Oritani Bank PNC Bank TD Bank Wells Fargo Bank Chase Bank New Jersey Cash Management

All depositories must conform to the Governmental Unit Deposit Protection Act (GUDPA) and shall provide a Notification of Eligibility from the State of New Jersey, Department of Banking, on a semi-annual basis. In addition, designated depositories shall maintain maximum FDIC or FSLIC coverage of all Borough funds on deposit.

## B. DEPOSIT OF FUNDS

All funds shall be deposited within forty-eight (48) hours of receipt, in accordance with NJSA 40A:5-15 into appropriate fund operating accounts. Non-interest bearing operating and capital accounts shall be regularly monitored for the availability of funds for investment. Debt Service and Trust accounts shall be maintained in accordance with Federal and State statues regulating such funds. Payroll, Developers' Escrow deposits and other agency funds, which represent funds of individuals and other organizations held by the Borough shall be deposited in regular, non-interest bearing checking accounts unless applicable State statues direct otherwise. Grant funds shall be deposited in accordance with regulations of the granting government or agency.

Where compensating balances are required by any designated depository to offset the cost of services provided, an agreement between the Borough and the depository shall be executed, specifying the charge for each service and the balance required to offset each charge.

C. INVESTMENT INSTRUMENTS AND PROCEDURES The Borough may purchase those investments permitted in N.J.S.A. 40A:5-15.1, which include:

United States Treasury Bonds, Notes, and Bills United States Government Agency and Instrumentality Obligations Bonds and other obligation of the Borough of Park Ridge Bonds and other obligations of the Park Ridge Board of Education Commercial Bank Deposits and Certificates of Deposit New Jersey Arbitrage Rebate Management Fund Savings Bank Deposits and Certificates of Deposit State of New Jersey Cash Management Fund

The Borough may purchase other obligations approved by the Division of Investment of the Department of Treasury for investment by local units.

Investments shall be limited to a maturity of not more than one year unless a longer term is permitted by applicable Federal or State regulations. Allowable investments with maturities which extend beyond the end of the Borough's fiscal year shall be permitted only if interest accrued on the investment is credited to the Borough at the end of the fiscal year for the purpose of realizing budgetary revenue.

The purchase of Certificates of Deposit shall be made based on the availability of funds for investment and the analysis of projected cash flows. Bids for Certificates of Deposit will be solicited from at least three designated depositories only if the amount available for investment is \$100,000 or greater. Telephone bids will be solicited by the Chief Financial Officer, or designated staff member. Bidders shall specify the principal amount, interest rate, and maturity of the investment. A check or wire transfer will be made available to the winning bidder on the same business day the bid is awarded. Where the return on a proposed investment does not exceed the cost of making such investment, the Chief Financial Officer will not make the investment. The Chief Financial Officer shall have the discretion to award an investment to the depository wherein the funds reside should that institution's quoted interest rate be less than other quoted rates and the differential in interest rates is not more than twenty-five (25) basis points (0.25%) providing that the term of the investment is thirty (30) days or less. The Chief Financial Officer shall have discretion to reject all bids.

#### D. DISBURSEMENT OF FUNDS

All funds shall be disbursed as authorized and directed by the Mayor and Council, except that the Chief Financial Officer shall have the authority to make disbursements prior to receiving the approval of the Borough Council in extreme emergencies where the safety of the public is jeopardized. In addition, the following disbursements may be made prior to receiving approval of the Mayor and Council:

For disbursements relative to payroll tax withholding, the Mayor and Council may authorize the use of a servicer to take possession of the local unit funds and execute the disbursements of the Borough to the taxing authorities. Tasks to be performed by the servicer may include report preparation, calculation of withholding and direct deposit of payroll disbursements.

The Chief Financial Officer is designated the "approval officer" responsible for authorizing and supervising the activities of the servicer. In cases where the servicer takes possession of local unit funds for payments of payroll claims, the approval officer is charged with ensuring that payments are made on a timely basis by regularly securing third party confirmation of such.

Disbursements shall be executed via electronic wire transfer of funds by the Chief Financial Officer, or designated staff member, when that method of payment will result in a financial benefit to the Borough in the form of increased investment income.

## E. AUTHORIZED SIGNATURES

Chapter 6 of the Code for the Borough of Park Ridge designates the Mayor, Borough Clerk, Deputy Borough Clerk, Borough Treasurer, and Assistant Borough Treasurer as the authorized signers of checks. All warrants or checks for the disbursement of money shall be made by three (3) of the authorized signers and facsimile signatures may be used. Payroll and Agency checks related to Salary and Wages shall be signed by the Borough Treasurer and facsimile signature may be used.

#### F. PETTY CASH FUND

Reimbursement for expenditures through the Petty Cash Fund shall be made within the limits approved by the Director of the Division of Local Government Services. The Petty Cash Fund shall be maintained in accordance with N.J.S.A. 40A:5-21. Individual reimbursements from the Petty Cash Fund shall not exceed \$50 per item. The following Petty Cash Funds shall be maintained:

#### G. BONDING

Staff members of the Department of Finance and Tax Collection not covered by separate surety bonds shall be covered by a Public Employee's Faithful Performance Bond.

H. COMPLIANCE

The Cash Management Plan of the Borough of Park Ridge shall be subject to the approval of the Borough's Legal Counsel, and shall be subject to the annual audit conducted pursuant to N.J.S.A. 40A:5-4

As stated in N.J.S.A. 40A:5-14, the official(s) charged with the custody of Borough funds shall deposit them as instructed in the Cash Management Plan and shall thereafter be relieved of any liability or loss due to the insolvency or closing of any designated depository.

If at any time this Cash Management Plan conflicts with any regulations of the State of New Jersey, or any department thereof, the applicable State regulations shall apply.

**WHEREAS**, although property is provided through the 1033 Program at no cost to municipal and county LEAs, these entities are responsible for the costs associated with delivery, maintenance, fueling, and upkeep of the property, and for specialized training on the operation of any acquired property; and

**WHEREAS**, N.J.S.A. 40A:5-30.2 requires that the governing body of the municipality or county approve, by a majority of the full membership, both enrollment in, and the acquisition of any property through, the 1033 Program; and

**NOW THEREFORE BE IT RESOLVED** by the Mayor and Council of the Borough of Park Ridge that the Park Ridge Police Department is hereby authorized to enroll in the 1033 Program for no more than a one-year period, with authorization to participate terminating on December 31 of the current calendar year from January 1, 2020 to December 31, 2020; and

**NOW THEREFORE BE IT FURTHER RESOLVED** that Park Ridge Police Department is hereby authorized to acquire items of non-controlled property designated "DEMIL A," which may include office supplies, office furniture, computers, electronic equipment, generators, field packs, non-military vehicles, clothing, traffic and transit signal systems, exercise equipment, farming and moving equipment, storage devices and containers, tools, medical and first aid equipment and supplies, personal protection equipment and supplies, construction materials, lighting supplies, beds and sleeping mats, wet and cold weather equipment and supplies, respirators, binoculars, and any other supplies or equipment of a nonmilitary nature identified by the LEA, if it shall become available in the period of time for which this resolution authorizes, based on the needs of the Park Ridge Police Department without restriction; and

**NOW THEREFORE BE IT FURTHER RESOLVED** that Park Ridge Police Department is hereby authorized to acquire the following "DEMIL B through Q" property, if it shall become available in the period of time for which this resolution authorizes controlled property items authorized for acquisition, including quantity, e.g., (1) utility truck, (12) 5.56 millimeter rifles, or (1) MRAP, etc.; and
