WHEREAS, in response to financial hardships created from COVID-19, municipalities throughout the state adopted changes to how they charge interest on delinquent taxes; and

WHEREAS, Governor Murphy issued Executive Order No. 130 on April 28, 2020, which states that no municipality shall enact or enforce any resolution in an attempt to otherwise temporarily fix, reduce, or retroactively modify the rate of interest on delinquent property taxes charged for failure to make timely payment; and

WHEREAS, Executive Order No. 130 states that any governing body of a municipality with a calendar year budget cycle may adopt a resolution instituting a grace period concluding on a date no later than June 1, 2020 for the payment of second-quarter property taxes; and

WHEREAS, property tax payments received after June 1, 2020 will be subject to an interest penalty calculated from May 1, 20202 as currently required; and

NOW, THEREFORE BE IT RESOLVED, that the Borough Council of the Borough of Park Ridge hereby institutes a grace period concluding June 1, 2020 for the payment of second-quarter property taxes; and,

BE IT FURTHER RESOLVED that the Municipal Clerk will transmit a certified copy of this resolution to the Director of the Division of Local Government Services in the Department of Community Affairs and the Tax Collector-Chief Financial Officer.

FINALLY, BE IT RESOLVED, a copy of this Resolution shall be placed on file in the Municipal Clerk Office, the Office of the Borough Administrator and a copy be transmitted to the Borough Attorney.

<u>Mayor Misciagna</u>: Basically, for those of you who heard the Governor today, he has extended the date to have your taxes in, until June 1st. He just gave that announcement a couple of hours ago. I think Park Ridge will have the honor of being the first town, in the State, to pass this Resolution locally.

<u>Mayor Misciagna</u>: We are going to do everything we can to help people get through this. Whether it's getting masks out to the residents, or extending their deadline on their utility or tax bills, Park Ridge is going to try to help our citizens' any possible way we can, so we are happy do that.

I would like to, at this point, to give some solemn news and talk about the Coronavirus. We are going to get through this. But, for those of you that don't know, I would like to give you some of the news from the State: As of last evening, state-wide, total tested patients were 204,651 and total positives equaled 111,188 and the negatives are 116,587. State-wide our death toll sits at 6,044. More locally, the County of Bergen has 15,266 presumptive positive cases, as of last night, affecting all 70 municipalities in Bergen County. We have had 960 county-wide deaths as of last evening. Park Ridge's total is 135 cases and 19 deaths.

Mayor Misciagna calls for a moment of silence for those individuals who have passed from this along with the families that are suffering. Thank you.

Our thoughts and prayers are with those families and we will continue to do everything we can here on our end to lighten their load.

SUSPEND THE REGULAR ORDER OF BUSINESS

<u>Mayor Misciagna</u>: Instead of suspending the Regular Order of Business, Mayor Misciagna announces that we will be swearing in our latest **Fire Department Member** - **Jason A. Taormina** at a later date. He will be starting immediately, but due to the Coronavirus, we will have Chief Lepore swear him in as quickly as possible. Then, at a future date, he can come to a Council meeting and we will take a picture with him and his family. We thanked him for his service and we ask him to be as safe as possible!

I would like to talk about the event that we had over the weekend. We hosted, as the hosting town, the **TankQue for Our Heroes.**

<u>Council President Mintz</u>: The event was held this Saturday, which actually started on Friday night with the cooking of the meat.

A CBS News clip was shared from this event: This event was in support of its' First Responders - it was a BBQ for Charity: It was a day of giving in Park Ridge as fresh foods were prepared for the Covid-19 Front Line Workers. Maintaining a safe distance, dozens of volunteers went to work cooking and cutting hundreds of pizzas and barbequing close to 1,000 pounds of pulledpork and grilled chicken. They then put all of the meals into boxes to feed 1,500 Health Care employees and First Responders. Steven Rich organized the event to support those fighting to save others. It all started Friday night with the volunteers preparing fire pits – it all then came together on Saturday with volunteers like Elysa Lovett coming together for one cause – this mission hits home as her brother was home on a ventilator, and nearly died from the virus. As she began running pizzas from the oven, local heroes started lining up in cars to get food. Some were even loaded into volunteer's vehicles and delivered to nearby hospitals. Firefighter, **Robert Paller** spoke "it makes me feel bad. I think people take for granted sometimes what they have right around the corner from them". An outpouring of support that shows no matter where you are in the country, people from all over are uniting as one to help. Mayor, Keith Misciagna "It is a very trying time, but I am very proud of our community" A message that did not go unmissed here ---- Here, in Park Ridge this is Cory James – CBS 2 News.

<u>Council President Mintz</u>: That's my message. The day and the event went very well. I think 1,500 meals were served. I was pretty much there all day and I made a delivery to The Atrium. It was a really great event - to see everything! I will talk more about The Atrium later in the meeting.

Mayor Misciagna: Thank you, Mike. It was a really great event! Obviously, we were a little concerned because we wanted to make sure everyone practiced social distancing. Steve Rich, the gentleman that arranged the event, he was a long-time Park Ridge resident and I think since moved out and to Montvale. But he organized it and it was amazing! People came out, they were there all day; especially working over a hot fire – it was wonderful to be part of it! I was just happy that we were able to participate in it. Thank you, Mike, for acting as the Liaison. I know you were there Friday night and you were there basically all day on Saturday. I think the Health Department was there 3 times during the day to make sure that everybody did the right thing. I am very grateful that they did that, and that they did that in a very safe manner. So, thank you. I appreciate it!

So, what we did was lower that revenue and adjusted that using our surplus. That is what we will be passing tonight in the Budget.

<u>Finance Committee Chairman Michael Mintz introduces Tom Madru, Treasurer of Public</u> Library & Municpal Pool – He will presents both 2020 Library & Municipal Pool Budgets

Tom Madru speaks on behalf of Tom Bauer/Municipal Pool Manager: I Would like to speak about Tom Bauer who has been our Pool Manager. He has been our Pool Manager for a very long time! I've been on the Commission for about twenty-five years and Tom has been the Manager that entire time. He has decided to step back and won't be on the front line quite as much anymore, but he is going to take on more of an advisory role for this year. So, you will see him around but he is stepping back and we are happy to announce that long-time Assistant Manager, Andrew Lewis, will be the new Pool Manager starting in 2020. I would like to just announce that and to also thank Tom for all his years of wonderful work and we will be glad to still see him around still some-what this season.

Finance Committee Chairman Michael Mintz: Thanks very much, Tom. I appreciate that. For those of you that don't know Tom Bauer or went to the High School, know him as Sr. Bauer. The next item on the Agenda is the Utility Board. I am going to turn it over to the Liaison to the Utility Board, Tom Farinaro.

<u>Finance Committee Chairman Michael Mintz Introduces Utility Board Liaison Tom</u> <u>Farinaro – Presents 2020 Water & Electric Utility Budgets</u>

Tom Farinaro: Thank you, Mr. Mintz. Before I begin, I just want to add a comment regarding Tom Bauer: Sr. Bauer was my teacher in high school. That's how long he has been around and involved!

Utility Board:

Mr. Farinaro starts by announcing the Officers to the Utility Board. I want to just make note that Dr. Charles Moore, who started the year out as our Utility Board President, passed away earlier this year. He was a long-time member or our Utility Board! Before moving on to the Water Department, I would just like to thank the Utility Department - they do a tremendous job!

Presents 2020 Water & Electric Utility Budgets:

Tom Farinaro presents both the 2020 Water & Electric Utility Budgets.

<u>Finance Committee Chairman Michael Mintz</u>: In the next part of the meeting, we will be Adopting the 2020 Municipal Budget.

<u>Mayor Misciagna</u>: The Mayor asks the Borough Administrator to announce the phone number to everyone watching, in case they have any questions. We will give everyone a few minutes to dial in and we will address those questions.

<u>Julie Falkenstern</u>: The conference call line is open – the number to call in is 201-822-3199 and the passcode is then 121212. The line is open now.

Mayor Misciagna: We will give everyone a few minutes in case they would like to call in. In the meantime, I would really like to thank everybody that just did those presentations. It's been an extremely difficult year – especially what's going on with the virus, just made it even more difficult, obviously. Mike, as the Chairman of the Finance Committee, I know you have put in an incredible number of hours with Councilman Metzdorf, as well as our new CFO, Durene Ayer - who's a super-star! I really appreciate it! We finally have our finances back in order after several years of difficulty, and I am extremely grateful. Thank you, we really appreciate it! Tom Madru, thank you for everything you do! The pool – it's a wonderful part of our community – it's one of those great Park Ridge "old town/kind of thing". We are hoping that this Pandemic doesn't affect it too much, but I know we are ready to go at a moment's notice if the Governor allows us. Mayor thanks Tom Farinaro with all his work with the Utility Board.

<u>Speaker: Will Fenwick – 5 Mae Court</u>: First, I would like to thank all the Borough employees, volunteers and emergency personnel for everything they have done, for us, in town, during this crisis. I have a couple questions regarding the Municipal Budget. I noticed that under the revenue for the hotel tax that we budgeted an additional \$20,000.00 in anticipated revenue, from the hotel tax, which is more obviously than we budged last year. I know its slightly less than what we actually collected, but given everything that is going on, with mass reductions in travel and what-not, is that quarter of a million-dollar budgeting of hotel tax revenues realistic in the Council's opinion?

Mayor Misciagna: Asks Finance Committee Chairman, Mike Mintz to answer.

<u>Finance Committee Chairman, Mike Mintz</u>: Originally when the Pandemic was hitting, and hotels were getting hit, we looked at lowering that amount. Because we didn't know what was going on, or anything, we were advised by our Auditor to basically stand pat at the moment. But then the State came in and said they needed us to lower that amount, and that's what we did with that Resolution tonight. And we will look at it further, because we really don't know what is going to happen with that.

<u>Mayor Misciagna</u>: Mentions to Mr. Fenwick if you look at Resolution No. 020-093, we lowered the anticipated revenue by 20%. So, we definitely addressed that.

Will Fenwick: My next question is in relation to the Budget for legal services. For 2019, there is a separate appropriation of \$200,000.00 for COAH litigation related legal services. There is nothing in the Budget for this year, in this year's column, but there is an increase to ordinary legal services of \$190,000.00. So, I was wondering: 1-what the anticipated cost of the COAH litigation is going to be in this Budget? 2-if that was wrapped into all of the legal services? And 3-and if not, why has the cost of legal services to the Borough gone up \$190,000.00?

<u>Finance Chairman, Mike Mintz</u>: So, as far as the legal services, they are put into our General Admin as far as the way the State has us position the Budget, and I can have Durene speak in more detail on that in a minute.

But the short answer is, we anticipated when preparing the Budget, more of potentially going to trial. Again, just like the opposite of the Marriott with the Covid, things have been put on hold, slightly with that. And so, again, we don't know what the status is of some of those fees.

CFO, Durene Ayer: I think what you are looking at is the emergency appropriation for the \$200,000.00, which is a separate line item under legal services. Legal services for the COAH Litigation is included in the other expenses, as it was last year. So, the additional line item that you are looking at: there's other expenses and then there is other expenses/COAH. That is if you look over, the \$200,000.00 is under the emergency appropriation. So, it is in there.

<u>Will Fenwick</u>: Is the reason it wasn't broken out this year because it was an emergency appropriation last year?

<u>Durene Ayer</u>: It wasn't broken out last year either.

Will Fenwick: It was just broken out for purposes of the emergency appropriation.

Durene Ayer: Correct.

Will Fenwick: Next question: What's the anticipated surplus, in the Budget, for this year?

Finance Chairman Mike Mintz: What we are using or what is remaining?

Will Fenwick: Remaining

Jeff Bliss: The remaining amount is \$807,000.00.

<u>Will Fenwick</u>: Okay. My last question is: Mike had mentioned - could we put off to the future if an emergency were to occur, given everything? As we were discussing some of these Budget items, we have no idea what actual revenues are going to be because of the ongoing crisis.

<u>Mike Mintz</u>: So, that is why we had the estimated costs. So, if there was some emergency, we could put off doing things. But the danger is – let's talk about people's roads. If you decide, for example, to put off paving roads, for example, because you need money elsewhere, that's a decision that the Council could make. The short answer is - there is a number of things in there that a lot of it's discretionary. Some of it, like repairing the pistol range, almost pay for itself. So, there is some things that are discretionary and there are some things that are smart choices. Right now the interest rates are also pretty low. What we are getting for bonding is a pretty low percentage rate. So, it's also not necessarily a bad time to do it.

<u>Will Fenwick</u>: I guess what I was really getting at was – are there old debts, in essence, that we are paying off now, that we could, if an emergency happened, we could defer paying those old debts off into the future?

<u>Jeff Bliss</u>: The debt service payments that we are making are all mandatory payments. We don't really have a choice to defer them.

Will Fenwick: There is no callable debt that we are paying off?

Jeff Bliss: There is callable debt, but they are not callable yet.

Will Fenwick: Okay.

<u>Jeff Bliss</u>: And in New Jersey, a called debt – there has to be a certain percentage of savings before they allow you to call them.

WHEREAS, the Borough intends to issue a \$2,564,400 bond anticipation note, dated May 1, 2020, payable April 30, 2021 (the "Note"); and

WHEREAS, the Borough desires to designate the Note as a "qualified tax-exempt obligation" pursuant to Section 265(b)(3) of the Code;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Park Ridge, in the County of Bergen, New Jersey, as follows:

SECTION 1. The Borough Council hereby covenants on behalf of the Borough, to the extent permitted by the Constitution and the laws of the State of New Jersey, to do and perform all acts and things permitted by law and necessary to assure that interest paid on bonds, notes and other obligations of the Borough (including the Note) be and remain excluded from gross income of the owners thereof for Federal income tax purposes pursuant to Section 103 of the Code.

SECTION 2. The Mayor, Borough Clerk, Chief Financial Officer and the other officials of the Borough are hereby authorized and directed to take such action, make such representations and give such assurances as they may deem necessary or advisable to effect compliance with the Code.

SECTION 3. The Note is hereby designated as a "qualified tax-exempt obligation" for the purpose of Section 265(b)(3) of the Code.

SECTION 4. It is hereby determined and stated that (1) said Note is not a "private activity bond" as defined in the Code and (2) the Borough and its subordinate entities, if any, do not reasonably anticipate issuing in excess of \$10 million of new money tax-exempt obligations (other than private activity bonds) during the calendar year 2020.

SECTION 5. It is further determined and stated that the Borough has not, as of the date hereof, issued any tax exempt obligations (other than the Note) during the calendar year 2020.

SECTION 6. The Borough will, to the best of its ability, attempt to comply with respect to the limitations on issuance of tax-exempt obligations pursuant to Section 265(b)(3) of the Code; however, said Borough does not covenant to do so, and hereby expressly states that a covenant is not made hereby.

SECTION 7. The issuing officers of the Borough are hereby authorized to deliver a certified copy of this resolution to the original purchaser of the Note and to further provide such original purchaser with a certificate of obligations issued during the calendar year 2020 dated as of the date of delivery of the Note.

THIS AGREEMENT made this 28day of April 2020, in the County of

Bergen State of New Jersey, By and Between the **Bergen Municipal Employee Benefits Fund** referred to as "FUND" and the governing body of the Borough of Park Ridge a duly constituted LOCAL UNIT OF GOVERNMENT, hereinafter referred to as "LOCAL UNIT".

WITNESSETH:

WHEREAS, the governing bodies of various local units of government, as defined in N.J.A.C. 11:15-3.2, have collectively formed a Joint Insurance Fund as such an entity is authorized and described in N.J.S.A. 40A:10-36 et. seq. and the administrative regulations promulgated pursuant thereto; and

WHEREAS, the LOCAL UNIT has agreed to become a member of the FUND in accordance with and to the extent provided for in the Bylaws of the FUND and in consideration of such obligations and benefits to be shared by the membership of the FUND;

NOW THEREFORE, it is agreed as follows:

- 1. The LOCAL UNIT accepts the FUND's Bylaws as approved and adopted and agrees to be bound by and to comply with each and every provision of said Bylaws and the pertinent statutes and administrative regulations pertaining to same.
- 2. The LOCAL UNIT agrees to participate in the FUND with respect to health insurance, as defined in N.J.S.A. 17B:17-4, and as authorized in the LOCAL UNIT's resolution to join.
- 3. The LOCAL UNIT agrees to become a member of the FUND and to participate in the health insurance coverages offered for an initial period, (subject to early release or termination pursuant to the Bylaws), such membership to commence on **January 1, 2020** and ending on **December 31, 2022** at 12:01 AM provided, however, that the LOCAL UNIT may withdraw at any time upon 90 day written notice to the FUND.
- 4. The LOCAL UNIT certifies that it has never defaulted on payment of any claims if self-insured and has not been cancelled for non-payment of insurance premiums for a period of at least two (2) years prior to the date of this Agreement.
- 5. In consideration of membership in the FUND, the LOCAL UNIT agrees that it shall jointly and severally assume and discharge the liability of each and every member of the FUND, for the periods during which the member is receiving coverage, all of whom as a condition of membership in the FUND shall execute an Indemnity and Trust Agreement similar to this Agreement and by execution hereto, the full faith and credit of the LOCAL UNIT is pledged to the punctual payments

of any sums which shall become due to the FUND in accordance with the Bylaws thereof, this Agreement or any applicable Statute. However, nothing herein shall be construed as an obligation of the LOCAL UNIT for claims and expenses that are not covered by the FUND, or for that portion of any claim or liability within the LOCAL UNIT retained limit or in an amount which exceeds the FUND's limit of coverage.

- 6. If the FUND in the enforcement of any part of this Agreement shall incur necessary expenses or become obligated to pay attorney's fees and/or court costs, the LOCAL UNIT agrees to reimburse the FUND for all such reasonable expenses, fees, and costs on demand.
- 7. The LOCAL UNIT and the FUND agree that the FUND shall hold all moneys in excess of the LOCAL UNIT's retained loss fund paid by the LOCAL UNIT to the FUND as fiduciaries for the benefit of FUND claimants all in accordance with N.J.A.C. 11:15-3 et. seq.
- 8. The FUND shall establish and maintain Claims Trust Accounts for the payment of health insurance claims in accordance with N.J.S.A. 40A:10-36 et. seq., N.J.S.A. 40A:5-1 and such other statutes and regulations as may be applicable. More specifically, the aforementioned Trust Accounts shall be utilized solely for the payment of claims, allocated claim expense and stop loss insurance or reinsurance premiums for each risk or liability as follows:
 - a) Employer contributions to group health insurance
 - b) Employee contributions to contributory group health insurance
 - c) Employer contributions to contingency account
 - d) Employee contributions to contingency account
 - e) Other trust accounts as required by the Commissioner of Insurance
- 9. Notwithstanding 8 above, to the contrary, the FUND shall not be required to establish separate trust accounts for employee contributions provided the FUND provides a plan in its Bylaws for the recording and accounting of employee contributions of each member.
- 10. Each LOCAL UNIT of government who shall become a member of the FUND shall be obligated to execute an Indemnity and Trust Agreement similar to this Agreement.

BERGEN MUNICIPAL EMPLOYEE BENEFITS FUND



ALLOCATION OF ANTICIPATED REVENUE








ALLOCATION OF EXPENDITURES





ANTICIPATED SOURCES OF REVENUE














